Junior Athlete Representative for 2008 will be elected during the Iowa Swimming Championships in Iowa City. The position requires a two-year commitment from the athlete. The athlete serves as Junior Representative for the first year of their term and becomes Senior Representative for the second year. Responsibilities would be to attend House of Delegates Meeting, ISI Board meetings, and share opinions and advise on issues that are of concern to the swimmers of Iowa.

A swimmer wishing to be nominated must 1) be an Athlete Member in good standing; 2) be sixteen years of age or at least a sophomore in high school; 3) be currently competing, or have competed during the three preceding years in the program of swimming conducted by ISI or another LSC; 4) reside in the Territory and expect to reside therein throughout at least the first half of the term.

All athletes interested in this position should submit (form APP-22) a brief paragraph stating why they want to be the Junior Representative, signed by athlete & parent along with name, address, phone, email, age, swim club & mail to the ISI office by **February 22nd**.

Iowa Swimming Scholarships – ISI presents three scholarships each year. Each recipient will receive a plaque and \$600 (payable to college – to be applied to their account).
