SWIMWEAR 102.9.1 change effective May 15, 2009: 102.9 Swimwear - .1 Design –

A. Swimsuits worn for all 12 & under age group defined competition shall not cover the neck; extend past the shoulder, nor past the knee.

B. Swimsuits worn for competition must be non-transparent and conform to the current concept of the appropriate.

C. The Referee shall have the authority to bar offenders from the competition until they comply with the rule.

SWIMWEAR effective immediately: The use of more than one swimsuit at a time during any USA Swimming sanctioned approved competition is prohibited. (Rules & Regulations require that USA Swimming's technical swimming rules conform to those of FINA.)

CLUB REMINDER – Effective January 1, 2009 change in Article 502.4.3 - Anyone who coaches athletes at a USA Swimming practice or competition must be a coach member of USA Swimming and must have satisfactorily completed safety training and background screening required by USA Swimming.
